DISPATCH IMMEDIATELY IN REGARDS TO THE DOOR BEING BARRICADED. AN UNKNOWN FROM WETHERSFIELD APPROACHED R/O IN WHICH SHE ADVISED SHE HAS NOT HAD CONTACT OR SEEN ANYBODY FROM 130 WETHERSFIELD FOR APROX. THREE DAYS. SHE FURTHER ADVISED THAT LINLEY LIVE THERE WITH HIS WIFE AND NEWBORN BABY. ARRIVED ON SCENE AT THAT TIME TO ASSIST R/O. R/O ATTEMPTED TO MAKE CONTACT WITH THE NEIGHBORS AT AND WETHERSFIELD WITH NEGATIVE RESULTS. ND R/O APPROACHED THE RESIDENCE AGAIN TO ATTEMPT TO MAKE CONTACT. R/O PEERED THROUGH THE WINDOWS ATTACHED TO THE FRONT DOOR FRAME TO ATTEMPT TO GAIN A BETTER VIEW OF THE INTERIOR WHEN R/O OBSERVED A M/W WALKING DOWN THE STAIRS TOWARDS THE DOOR. PRIOR TO THE SUBJECT OPENING THE DOOR R/O OBSERVED HE WAS A M/W WITH A BEARD WEARING DIGITAL DESERT CAMOFLAUGE PANTS AND GREEN T-SHIRT WITH A 10-12 INCH BAYONET STYLE KNIFE SECURED TO HIS MILITARY STYLE GREEN BELT ON HIS RIGHT SIDE. THE SUBJECT REMOVED THE BENCH, UNLOCKED THE DOOR, AND SPOKE WITH R/O THROUGH THE STILL CLOSED SCREEN DOOR. THE SUBJECT IDENTIFIED HIMSELF AS 9-LINLEY AND QUESTIONED R/O'S ARRIVAL AT THE RESIDENCE. R/O EXPLAINED THE REASON FOR AND R/O BEING AT HIS RESIDENCE AND ATTEMPTED TO ASCERTAIN HIS WELL BEING. R/O WAS QUESTIONING 9-LINLEY IN REGARDS TO THE LOCATION OF HIS WIFE AND CHILD. 9-LINLEY ADVISED THEY WERE AT HIS MOTHERS AND WOULD PROVIDE A TX FOR THEIR LOCATION. UP TO THIS POINT 9-LINLEY APPEARED CALM, POLITE, AND COOPERATIVE. WHILE SPEAKING WITH 9-LINLEY, R/O WAS OVERCOME BY A VERY STRONG ODOR OF NATURAL GAS EMINATING FROM INSIDE OF THE RESIDENCE. R/O IMMEDIATELY NOTIFIED WHO WAS APROX. 8-10 FEET BEHIND R/O, OF THE ODOR IN WHICH HE CONFIRMED THAT HE TOO SMELLED THE NATURAL GAS. R/O ORDERED THE SUBJECT TO EXIT THE RESIDENCE. AT THAT MOMENT THE SUBJECT SLAMMED THE DOOR, LOCKED IT, AND RESECURED THE WOODEN BENCH TO BARRICADE THE DOOR. 5-LINLEY PROCEEDED TO WALK BACK TOWARDS THE INTERIOR OF THE RESIDENCE APROX. 3-4 STEPS WHEN HE STOPPED AND SUDDENLY BENT DOWN AT THE BASE OF THE STAIRS AND APPEARED TO REACH FOR AN UNKNOWN ITEM. DUE TO 9-LINLEY'S ACTIONS, STYLE OF DRESS, KNIFE ATTACHED TO HIS BELT, RAPID CHANGE OF DEMEANOR, AND ODOR OF GAS, AND R/O IMMEDIATELY RETREATED TO FIND COVER FOR OFFICER SAFETY AND TOOK UP POSITIONS R/O INFORMED DISPATCH OF THE RAPIDLY EVOLVING SITUATION, GAVE THE SUBJECTS DESCRIPTION, AND ACTIONS. OFFICERS BEGAN TO ARRIVE ON SCENE AND TAKE UP PERIMETER POSITIONS AROUND SAID RESIDENCE. R/O TOOK UP A POSITION AT A TREE IN THE FRONT OF 136 WETHERFIELD. R/O OBSERVED THE NORTH WINDOW ABOVE THE GARAGE AT 130 WETHERSFIELD OPEN, BY 9-LINLEY.

OFFICERS IN THE REAR PERIMETER OBSERVED A REAR UPPER WINDOW ON 130 WETHERSFIELD BEING OPENED AT THAT TIME AND BROADCASTED THE INFORMATION OVER THE RADIO. A SHORT TIME LATER R/O THEN HEARD GUNSHOTS COMING FROM THE INTERIOR OF THE RESIDENCE TO THE EXTERIOR IN A WESTERLY DIRECTION. R/O HEARD GUNSHOTS COMING FROM THE INTERIOR OF THE RESIDENCE TO THE EXTERIOR IN THE DIRECTION OF SQUAD CAR, WHICH WAS PARKED, ON THE WEST SIDE OF THE STREET FACING NORTH BOUND BETWEEN 137 AND 143 WETHERSFIELD. R/O HEARD APPARENT IMPACTS ON SQUAD CAR AT THE TIME THE SHOTS WERE BEING FIRED FROM THE RESIDENCE. THE GUNSHOTS COMING FROM THE RESIDENCE WERE ALSO IN THE DIRECTION OF WHICH WAS PARKED ON THE EAST SIDE OF THE STREET FACING NORTHBOUND AT 142 WETHERSFIELD. R/O HEARD APPARENT IMPACTS FROM PROJECTILES STRIKING SQUAD CAR SIMULTANEOUSLY AS THE GUNSHOTS WERE BEING FIRED FROM 130 WETHERSFIELD R/O'S SQUAD CAR WAS ON THE WEST SIDE OF THE STREET FACING SOUTHBOUND DIRECT IN FRONT OF 130 WETHERSFIELD. R/O HEARD GUNSHOTS COME FROM THE INTERIOR OF 130 WETHERSFIELD AND SIMULTANEOUSLY OBSERVED THE DRIVERS SIDE WINDOW ON R/O'S SQUAD SHATTERING. R/O COULD ALSO HEAR GUNSHOTS COMING FROM THE REAR OF 130 WETHERSFIELD AND ADVISING VIA THE RADIO THEY WERE PINNED DOWN RECEIVING DIRECT FIRE FROM 5-LINLEY. THE SCENE WAS TURNED OVER TO WHEN HE ARRIVED ON SCENE. ADVISED R/O TO

TAKE UP A BETTER POSITION TO OBSERVE THE TWO WESTERLY WINDOWS ABOVE THE GARAGE ON 130 WETHERSFIELD WHERE 9-LINLEY WAS SHOOTING FROM. R/O WAS OF WETHERSFIELD AND COULD HEAR MULTIPLE GUNSHOTS COMING OUT OF THE FRONT AND REAR OF 130 WETHERSFIELD. R/O ARRIVED AT THE WETHERSFIELD AND A SHORT TIME LATER JOINED BY ENTRY WAS MADE INTO THE REAR OF WETHERSFIELD AND AND R/O TOOK UP POSITION IN THE 130 WETHERSFIELD. AND ADVISED THEY WERE RECEIVING CONSTANT DIRECT GUNFIRE STRIKING THEIR POSITION. A SHORT TIME LATER R/O WAS JOINED BY WHO ALSO TOOK UP POSITION IN THE DEPLOYED HIS WEAPON IN THE WAS PROVIDING AND R/O WAS SPOTTING FOR FURTHER INTELLIGENCE. R/O OBSERVED 9-LINLEY STANDING UP AND LEANING OUT OF THE NORTH WINDOW ABOVE THE GARAGE AND FIRING NUMEROUS SHOTS NORTHBOUND TOWARDS OTHER OFFICERS ON SCENE. R/O THEN OBSERVED 9-LINLEY CHANGE DIRECTION AND PROCEED IN FIRING NUMEROUS SHOTS SOUTHBOUND AT LOCATION AT THE FRONT OF WETHERSFIELD. R/O OBSERVED 9-LINLEY WAS YELLING " AND WHEN WOULD RESPOND HE WOULD FIRE A SHOT IN HIS DIRECTION. FIRED ONE SHOT FROM HIS WEAPON IN THE DIRECTION OF 9-LINLEY WHO WAS SHOOTING FROM THE NORTH WINDOW ABOVE THE GARAGE. R/O OBSERVED THE SUBJECT GO ACROSS THE WINDOW AND THEN OUT OF SITE.
